## **Privacy policy for clients, suppliers, and collaborators.**

At PIRCO, the security of your information is very important to us, and we are committed to protecting the information we collect from your company; For this we have implemented necessary technical, organizational and legal security measures, which protect against the improper use or alteration of the information collected and will not use the information provided by you for purposes other than those described here or within the document stating the legal relationship between your company and PIRCO.

PIRCO, in consideration of the end user, we decree the following:

- 7) All our collaborators and suppliers are obliged not to disclose confidential information of our clients or suppliers, if needed, the necessary measures are taken in accordance with the law, confidentiality, and non-disclosure agreements.

Our records are made up of information provided directly by you and information available in public records. The specific purposes for which we use your information internally is as follows:

- Inform you about relevant products or product groups.
- Analyze transactions or a possible contractual relationship of any nature for better service.
- Detect, investigate, and prevent activities that may violate our policies or be illegal and / or to comply with any legal provision to which PIRCO is subject, either in Mexico and / or in any other jurisdiction.
